2016 Assessment Payments

When our neighborhood voted to amend the Thunderbird North Deed Restrictions in 2015, homeowner assessments were increased to \$175 per year. The vote included a provision that homeowners have the option to split their payment into two payments of \$87.50 each – one due on or before January 1 and the other due on or before July 1. If you overlooked your January payment (either full or partial amount), please be aware that your past due balance will be assessed \$1 per month interest until your account is brought up to date. You will receive an updated statement from the association during the first quarter of 2016 if you are past due.


Deed Restrictions Committee: New Solid Waste Service

Missouri City has signed a new solid waste service agreement with WCA which began at the first of the year. There is an excellent video at the city's website, <u>missouricitytx.</u> <u>gov</u>, which details the policies and procedures for the new service. For Thunderbird North, our schedule for service is:

Trash:	Every Monday & Thursday
Yard Waste:	Every Thursday
Recycling:	Every other Thursday
	(For February, dates are 2/4 and 2/18)
Bulk Waste:	Every other Thursday
	(For February, dates are 2/4 and 2/18)

Trash should be placed in the provided blue bins so that the lid closes, and recycling in the grey bins. Yard waste may be either bundled in 4" bundles, placed in your old waste bins, or placed in compostable bags, such as paper kraft bags (available at most hardware stores). As a reminder, store the trash cans where they are not visible from the street. The city will be strictly enforcing.

Missouri City Police Dept.

In the last month a serial burglary was responsible for multiple offenses in Missouri City as well as Sugar Land. This suspect entered unlocked side garage doors overnight and stole anything of value he could find inside. There were 2 lessons learned from these events. First even if you close your main garage door, ensure you are locking the side doors as well to keep yourself protected. Second he was identified and subsequently apprehended due to being captured on video from a homeowner's security cameras. If you have security cameras on your home you can register to be a "Silent Partner" with the Police Department. If we have an offense in your area we then have the ability to contact homeowners with camera systems and see if they captured any suspect or suspect vehicle footage. Missouri City Launches SeeClickFix "iReport" Mobile App

This month, Missouri City launched an online and mobile smart phone application through SeeClickFix.com called "iReport" that allows citizens to report code enforcement violations. Using GPS to identify a citizen's location, the application is also aided by submitted photos residents can take using their smart phones. "Once a resident has reported an issue, iReport will contact the corresponding Code Enforcement Officer via email for further review," Code Enforcement Supervisor Ron Wrightsil said. "The application also allows residents to track the status of their complaint, receive progress reports and comment on other complaints."

The new application is available for free in the app store for iPhone and Android phones; citizens can download the application by searching "Missouri City iReport". Issues can also be reported and tracked online at SeeClickFix. com/Missouri-City. "This new application is the result of a successful collaboration between many City departments, and we hope this project is one of many news ways we utilize growing technology to benefit residents," Missouri City Police Chief Mike Berezin said.

Missouri City Code Enforcement Staff will respond to iReport service requests regular business hours Monday-Friday from 8 a.m. – 5 p.m.; requests submitted after 5 p.m. and during the weekend will be addressed the following business day. Missouri City Code Enforcement Officers will respond to each report on a case-by-case basis; if no violation or if a warning is given, the Officer will note this on iReport. Officers will also report when the issue has been fixed or the violation has been abated. SeeClickFix.com monitors for derogatory and/or abusive language and may remove a post or revoke posting privileges for individuals who violate guidelines. Non-emergency issues that require immediate attention need to be reported to the Police Department's non-emergency number: 281.403.8700.

Local Election Day: MAY 7

Missouri City's two At-Large council positions are included in the 2016 election that voters will decide on Election Day -- Saturday, May 7, 2016.


It has been several years since a resident of

Thunderbird North served on the Missouri City City Council – many of you may remember when Scott Moseley served our neighborhood in that capacity. This year, a resident of Thunderbird North has announced her candidacy for Council Member At-Large Position 2. Susan Soto, a resident of Thunderbird North for 5 ¹/₂ years with her husband Pete, filed her application for a place on the Missouri City ballot on February 1.

While over 11,000 people are registered to vote in Missouri City's District B (which includes

Thunderbird North), less than one thousand votes were cast in the 2015 race for District B Council Member – just over 600 in early voting and less than 400 on election day. In its official capacity, the TBNCA Board of Directors will remain neutral in all positions up for election this year, but the board encourages ALL eligible residents to register to vote before the voter registration deadline of April 7, 2016 and to cast their vote in the May 7, 2016 limited election, which will decide the mayoral race as well as both races for at-large city council positions. Your vote is your opportunity to be heard, to hold elected officials accountable for their decisions and to have a say in important issues that affect our community. On Election Day, every vote matters – especially yours!
