## **SKYWAY TOWERS PARTNERSHIP** WITH TBNCA

Many of our residents have noticed the "pine tree" technology that has been erected next to the tennis courts on Turtle Creek Drive. This is a cell tower built by Skyway Towers to host various cell phone companies' anntennae.

#### 1. Why was the cell tower built?

Missouri City is growing. As recently as the 2018 State of the City address, former mayor Allen Owen said that the city's population continues to grow as more people move to the city, and business development is thriving.

The demand for wireless services is also growing. There are more smartphones, laptops and tablets than people in the U.S., and Americans are using 35 times the data they were using only five years ago.

#### 2. What does this mean for me?

The average Missouri City household has multiple mobile devices. Many homes have disconnected their landlines and rely solely on mobile devices. Missouri City residents need 911 wireless connectivity, because over 85% of 911 calls are made by wireless devices! The city's MissouriCityReady alert system sends alerts, notifications and updates to email and mobile devices. Fort Bend ISD sends out emergency alerts to parents/guardians, as well as attendance and general alerts, by phone call, email or text message.

3. Why was the tower built in our neighborhood? Skyway Towers has certified to the city that the company does not have any towers within the city or within one mile of the city's borders. No towers are located withing the T-Mobile search area that are as tall as, or taller than, our tower. The Lantern Lane Elementary School area was considered as a possible site, but they/the school district was not interested. Skyway approached the TBNCA Board of Directors several years ago, and we indicated that we were interested in possibly partnering with the company. Our neighborhood is in a good location to improve connectivity in the city, based on several test measures. You can access those test reports on our website, in the Skyway Towers presentation packet.

#### 4. Is it safe?

Yes! The World Health Organization has determined that there is no correlation between emissions from mobile towers and public health. In 2016, J.S. Deepak, India's telecommunications secretary and formerly of Johns Hopkins University, stated that cell towers emit less radiation than sunlight and are "absolutely safe." The American Cancer Society's position is that most scientists agree that cell phone antennas or towers are "unlikely to cause cancer."

#### 5. But why does it look like a tree?

The TBNCA Board of Directors was adamant from the beginning that we did not want an industrial-looking apparatus in our neighborhood. Skyway worked hard to design a tower that is well camouflaged and much more pleasant to the eye.

#### 6. What are we getting out of it?

Per the lease agreement, Skyway Towers will pay TBNCA \$700 per month (\$8400 per year) in order to install and maintain the wireless communications tower. The initial term of the contract is five years, with a right to renew for ten successive five-year periods. The tower will be removed at the expiration of the agreement.

This money will help us 1) operate our association and provide activities and amenities for everyone's enjoyment; 2) provide a cushion in the budget for homeowners who are delinquent or otherwise do not pay their annual assessments; 3) preserve our investments held at Merrill Lynch; and other benefits.
